Call for applications for the following position:

### 1 Medical Device Expert Pharmacist (Ref. FEDM/17)

UPMC Italy offers professional opportunities in an international and multicultural setting at ISMETT, Istituto Mediterraneo per i Trapianti e Terapie ad Alta Specializzazione, one of the most innovative and technologically-advanced Italian facilities, managed by the University of Pittsburgh Medical Center (UPMC) and Civic hospital. In September 2014, ISMETT was acknowledged as Istituto di Ricovero e Cura a Carattere Scientifico (IRCCS) in the area of "End-stage organ failure treatment and research".

The Medical Device Expert Pharmacist is responsible for the analysis, planning and the qualitative and quantitative assessment of medical device needs, and for the preparation of the technical documentation for tendering and contracting procedures. He/she provides also guidelines on the use, storage and management of medical devices to monitor consumption and rationalize expenditure.

#### Requisites:

- University Degree in Pharmacy or equivalent title
- Specialization in hospital pharmacy or equivalent
- Pharmacist licensure
- Enrollment in the Board of Pharmacists
- Documented work experience in a hospital setting of at least 3 years in the field of medical devices

The ideal candidate has a good knowledge of English and a good knowledge of computer applications, as well as a good Knowledge of Italian laws and regulations on hospital pharmacy, including medical devices.

Good communication and interpersonal skills, good problem solving and organizational skills, good time and stress management skills, confidentiality, critical thinking, teamwork, and flexibility are also instrumental to the role.

Should any preliminary verification demonstrate any discrepancy with the statement and self-certification of the applicant, hiring will not take place.
