UPMC Italy offers professional opportunities in an international and multicultural setting at ISMETT, Istituto Mediterraneo per i Trapianti e Terapie ad Alta Specializzazione, one of the most innovative and technologically-advanced Italian facilities, managed by the University of Pittsburgh Medical Center (UPMC) and Civico hospital. In September 2014, ISMETT was acknowledged as *Istituto di Ricovero e Cura a Carattere Scientifico* (IRCCS) in the area of "End-stage organ failure treatment and research".

We are seeking young newly-specialized physicians interested in embarking on a fellowship program in the field of abdominal surgery and abdominal organ transplantation. The fellowship consists in a two-year contract and provides for an initial evaluation for admission and periodical evaluations.

The Abdominal Transplantation and Abdominal Surgery Fellow, under the supervision of the Director of the Treatment and Study of Abdominal Diseases and Abdominal Transplants Department, will participate in the care of, but not limited to, organ transplant patients. The Fellow will also cooperate with other physicians in the Istituto's clinical activities.

#### **Requisites:**

- Degree in Medicine and Surgery or equivalent title obtained from a foreign university, recognized in Italy.
- Postgraduate diploma in General Surgery or equivalent title recognized in Italy, already obtained, or in any case to be obtained within the current year.
- Enrollment in the professional board.

## Preferred qualifications:

- Broad experience in general surgery.
- Case-based experience in liver, kidney and pancreas transplantation.
- Previous experience in other organ transplant centers.
- Scientific production rated with the H-index.
- Attendance to training programs related to the position.

Good English proficiency, knowledge of main computer applications, availability to spend training periods abroad, high motivation, flexibility, stress management, problem-solving skills, and good interpersonal, communication, and teamwork skills are also instrumental to the role.

## The **workplace** is Palermo.
