## 1 Clinical Psychology Fellow (Ref. FellowPsico/18 TD)

UPMC Italy offers professional opportunities in an international and multicultural setting at IRCCS-ISMETT, Istituto Mediterraneo per i Trapianti e le Terapie ad Alta Specializzazione S.r.l., one of the most state-of-the-art and technologically-advanced Italian facilities, managed by the University of Pittsburgh Medical Center (UPMC) and Civico hospital.

The fellowship consists in a two-year contract and provides for an initial evaluation for admission and periodical evaluations.

The Clinical Psychology Fellow works under the direction of the Director of Clinical Psychology Service, and cooperates with OPC and inpatient psychological consults, and administration of clinical tests.

The selected candidate will provide psychological support to the patients and their families, and, if necessary, will start short-term psychotherapy. He or she provides also psychological assessment to transplant candidates, and guarantees the privacy of all the people involved in the transplantation process. The candidate will also participate in the research activities and quality projects of the institute in the scope of his or her subject.

## Requisites:

- Specialty/Master's Degree (new system) or university degree (old system) in Psychology. Qualifications must be recognized in Italy.
- Psychotherapy postgraduate diploma (recognized in Italy) or equivalent title.
- Enrolled in the professional register.

The ideal candidate has documented experience as hospital psychologist, in Italy or abroad, conducted research in psycho-oncology and/or clinical psychology for organ transplantation, and has good knowledge of psychological testing tools. Good knowledge of written and spoken English, and main computer systems.

High motivation, flexibility, stress management, problem-solving skills, priority and objective identification skills, and good interpersonal, communication and teamwork skills complete the profile.
