We are seeking specialized cardiologists interested in providing their professional consulting in the areas of Clinical Cardiology and Cardiac Rehabilitation at UPMC Institute for Health Chianciano Terme (Siena).

The Cardiologist will work with the Director of Cardiology and Cardiac Rehabilitation, and the UPMC Italy Chief Operating Officer in clinical activities, diagnostic tests, experimentation, and research.

Requisites:

- Degree in Medicine and Surgery recognized in Italy or equivalent title pursuant to the law.
- Postgraduate diploma in Cardiology recognized in Italy or equivalent title pursuant to the law.
- Enrollment in the Italian Board of Physicians.

The ideal candidate has good English proficiency, strong inclination for scientific and research activities, and knowledge of the main computer applications.

Preferred qualifications:

- Experience with experimentation and research.
- Training or professional experience in Cardiac Rehabilitation.
- Attendance at training programs related to this position.
- Scientific production rated with the H-index.

Strong motivation, flexibility, stress management, problem solving, ability to identify priorities and goals, teamwork, and interpersonal skills complete the profile.
