PRIVACY POLICY

The following information is provided, pursuant to art. 13 of the Personal Data Protection Code (Legislative decree 196 of 30 June 2003), to all the users of services accessible from www.ismett.edu (hereinafter "Website"). When consulting the Website, users' personal data may be collected pursuant to the Personal Data Protection Code. This Information Note is provided only and exclusively for the Website, and not for other sites that may be reached by users through links that are visible on the Website.

CO-DATA CONTROLLERS

Co-data controllers are Istituto Mediterraneo per i Trapianti e Terapie ad Alta Specializzazione and UPMC Italy, both with registered offices in Discesa dei Giudici 4, 90133 Palermo, Italy (hereinafter "ISMETT" and "UPMCI" or "Co-data controllers").

LOCATION OF DATA PROCESSING

Data processing associated with the web services of the Website is conducted at the clinical premises of ISMETT, in Via Tricomi 5, 90133 Palermo, Italy, by staff duly designated as data processors.

TYPES OF PROCESSED DATA

Browsing data

During regular operations, the computer systems and software procedures used to operate the Website, acquire personal data whose transmission is implicit in the use of Internet communication protocols. This information is not collected to be associated with identified subjects. However, due to its nature, this information may allow to identify users, through the processing and association with third-party data. Such data includes IP addresses or domain names of computers used by users connecting to the Website, URI (Uniform Resource Identifier) of requested resources, time of request, method used to submit requests to the server, size of file received in reply, numerical code indicating status of response from the server (e.g., successful, error, etc.), and other metrics concerning the operating system and the user IT environment.

Data is only used to obtain anonymous statistical information on the Website, and to check its correct functioning, and is deleted immediately after processing. Data could be used to ascertain responsibility in case of potential cybercrimes against the Website. With the exception of this specific case, data on web contacts is currently stored for a maximum of 4 weeks.

Data supplied voluntarily by users

The optional, explicit, and voluntary submission of electronic mail to the addresses stated on the Website, or when filling out the on line forms, implies the acquisition of the e-mail address and other personal data included in the message, and the sender/user data required to fulfill a reservation inquiry or provide requested services. Specific summary information shall be provided for particular services.

OPTIONAL DATA SUBMISSION

With the exception of browsing data, users are free to provide personal data to request information material or receive communications. Failure to provide personal data could result in the impossibility to process the user's request.

METHODS OF DATA PROCESSING

Personal data is processed using automated systems for the time strictly necessary to perform the tasks for which they have been collected. Specific safety measures are in place to prevent data loss, illegal or improper use, and unauthorized access.

PURPOSES OF DATA PROCESSING - DATA COMMUNICATION AND DISCLOSURE

Personal data provided by users requesting information material or services is used only to provide the service or information, and may be disclosed to co-data controllers' employees and collaborators working in the relevant departments and duly appointed as data processors, and to third parties providing ancillary services or instrumental to the activity of the co-data controllers, appointed as data controllers. With the exception of these cases, however, data will not be disclosed, unless this is required to comply with requests from judicial or public security authorities. Collected data will under no circumstance be disclosed.

RIGHTS OF THE PERSONS CONCERNED

Data subjects, pursuant to art. 7 of the Personal Data Protection Code, are entitled at all times to obtain confirmation as to whether or not their data exists, to be informed of its contents and source, verify its accuracy, or request its

Under the same article, the persons concerned are also entitled to request the cancellation, anonymization, or blocking of data processed unlawfully, as well as to object, in all cases and on legitimate grounds, to data processing.
