### **1 Software Analyst (Rif. AP/18 TD)**

Under the supervision of the Chief Information Officer, the Software analyst supports the Senior Developer in drafting the software logic design and program patterns, defines the programming needs and translates them into codes, participates in software developments using rapid prototyping and object-oriented techniques. The Software analyst is also in responsible for the definition/realization of software management procedures (e.g., launch, back-up, recovery), reporting the developed programs, and participates in the end-user operational implementation (manual and/or on-line help), carries out first-level tests or manages their performance, and is involved in proof tests and documentation of proof tests.

The selected candidate will join a motivated and dynamic team to develop highly technological projects.

#### **Requisites:**

All applicants will be expected to possess the following requirements:

- Degree in IT recognized in Italy.
- Minimum two-years professional experience in .Net programming.

#### **Preferred qualifications:**

- Ph.D. on subjects related to IT area.
- Experience in a clinical setting.

The ideal candidate has good knowledge of C# and/or JAVA, .NET Framework and/or JAVA EE, MVC pattern, HTML5/ CS, App development for Android smartphone, Object-Relational Mapping (ORM), Oracle DB, SQL Server DB, SQL Server Reporting.

English proficiency, discretion, excellent problem solving skills, flexibility, stress management, emergency management, good communication, and interpersonal skills are also instrumental to the role.
