

# IRCCS ISMETT

is issuing a call for applications for the selection of

## Nurse (Ref. Inf/19 I)

The purpose of this call is to create a list, which will have a validity of 36 months, of a maximum of 150 eligible candidates ranked in order of merit, to which IRCCS-ISMETT reserves the right to refer to for potential future working contracts.

ISMETT (Istituto Mediterraneo per i Trapianti e le Terapie ad Alta Specializzazione) is a state-of-the-art and one of the most technologically-advanced hospitals in Italy, managed by UPMC (University of Pittsburgh Medical Center) in partnership with Civico Hospital and the Ri.MED Foundation. The Italian Ministry of Health acknowledged ISMETT as an Institute for scientific-based care and treatment (IRCCS) in the area of "End-stage organ failure treatment and research."

Under the supervision of the clinical coordinator of the unit of reference, the nurse provides prompt, intensive, and continuous care to patients, according to the IRCCS-ISMETT policies.

Requisites and preferred qualifications must be specified in the on-line form.

### Requisites:

All applicants are expected to possess the following requisites at the time of application:

- University degree qualifying for the nursing profession, or equivalent title.
- Enrollment in the Italian Board of Registered Nurses (OPI).

### Preferred qualifications:

- University degree with a final mark of 105/110 or higher (candidates are requested to state their final mark upon submitting their application).
- First-level specialization in Critical Care.
- Work experience in ICU, OR, cardiac surgery, and abdominal surgery units.
- Work experience abroad.

**Complete the profile:** English proficiency, knowledge of main Office applications, excellent teamwork and stress management skills, and an availability to spend training periods abroad, are instrumental to the role.

Only applicants who are not excluded under the provisions articulated in Legislative decree 165/2001, Art. 53, para. 16-ter, and subsequent modifications and amendments, can participate in this selection (General Rules Governing the Work of Public Administrations - <https://www.ismett.edu/wp-content/uploads/2017/12/Explanatory-notes-to-art.53-para.-16-ter-of-legislative-decree-1652001.docx>).

The workplace is **Palermo**.

Information concerning this selection will be notified to candidates through the official website in the "Work with us" section (<https://www.ismett.edu/en>).

The date and location of the tests and/or interviews will be published on [www.ismett.edu](http://www.ismett.edu).

Candidates will be expected to access this information from the above mentioned website. Candidates failing to show up for the tests and/or interviews on the scheduled day, time, and location will be excluded from the selection, whatever the cause of their absence, even if these are beyond their control or due to causes not ascribable to them.

IRCCS-ISMETT reserves any and wider sole right of discretion in assessing the candidates to be included in the list of eligible individuals.

After reading the privacy statement and authorizing the processing of their personal data (EU Regulation 2016/679), applicants of either sex (Law 903/77) are requested to fill out the on-line application form, indicating the reference code, available at <https://selezioni.ismett.edu/?lang=en>.

The on-line form must be filled out paying particular attention to the requisites and preferred qualifications indicated in this call for application. Incorrect, unclear, or incomplete information in the on-line form could result in a non-eligibility for the test/interviews. When filling out the on-line application form, applicants will be requested to attach their CV. Applicants will also be requested to state, by means of a self-declaration, their possession of the requisites listed in this call for applications. Please note that the information provided in the on-line application form will be used to evaluate the application, and the candidate's consequent admission to the test/interviews.

IRCCS-ISMETT declines any responsibility for lack of communication due to incorrect e-mail addresses provided by candidates upon submitting their on-line application.

The deadline to submit the applications is **May 3, 2019**.

Please note that only applications submitted on-line will be taken into consideration (<https://selezioni.ismett.edu/?lang=en>).

Please note that selection records are confidential documents for internal use only, and may not be disclosed.

All candidates applying for this selection, and who have stated their possession of the requisites listed under this call, will be summoned for a written multiple-choice test. Under penalty of exclusion, candidates must show up (location to be disclosed according to the above method) on the scheduled day and time, with a valid ID. It is absolutely forbidden for candidates, under penalty of exclusion, to enter mobile phones, tablets, smart watches, or any other device for data storage, reception, or transmission inside the premises where the tests will be carried out. This prohibition is extended to all devices, even if these are switched off, deactivated or non-operating. We regret to inform candidates that we are unable to provide wardrobe or luggage storage service on the premises. Candidates are therefore kindly requested to leave all unauthorized items outside the selection room.

All applicants are obliged, at any time during the selection process, and if requested by IRCCS-ISMETT, to provide the documentation certifying the stated possession of the requisites within the requested deadline.

Should any preliminary verification show a discrepancy with any statement submitted by the applicant, the latter will be excluded from the selection process, and any negotiation deemed permanently suspended.

A list of suitable candidates will be drafted with no more than 150 eligible candidates ranked

in order of merit, with a validity of 36 months to which IRCCS-ISMETT reserves the right to refer to for potential future working contracts. The list will contain the names of the persons deemed eligible at the sole discretion of IRCCS-ISMETT. The inclusion on this list entails no right to working contracts and/or working relationships with IRCCS-ISMETT, nor a right of priority with respect to positions offered during previous and different selections or lists of candidates at IRCCS-ISMETT.

IRCCS ISMETT reserves the right to revoke and/or invalid, or definitively suspend the selection or list of candidates at any time, with no obligation to notify candidates and with no right for the latter to raise any right or claim whatsoever.

Applications from candidates that, due to previous fixed-term employment contracts with ISMETT IRCCS for the same position of Nurse, have reached the maximum time limit of 24 months pursuant to art. 19, paragraph 2 of Legislative Decree No. 81/2015 as amended by art. 1 of Legislative Decree No. 87, converted with amendments by Law No. 96 of August 9, 2018, will not be taken into consideration.

Personal data included in the CVs and any other information collected during the selection will be processed by IRCCS-ISMETT and UPMC Italy S.r.l. in their role of joint controllers, for selections for this or other similar positions. Applicants are requested not to include special categories of personal data (e.g., health status), unless strictly necessary.
