

## PRIVACY STATEMENT PURSUANT TO ART. 13 OF EU GENERAL DATA PROTECTION REGULATION 2016/679

IRCCS ISMETT and UPMC Italy, in their roles of data controllers, inform you that pursuant to art. 13 of the EU Regulation 2016/679 of the European Parliament and Council of 27 April 2016 ("Regulation") personal data (and those of your accompanying person) that you provided filling out this form to benefit from the Discounted Airfares offered by VOLOTEA airlines, as well as any other data that you will provide for the mentioned Discounted Airfares, will be used exclusively for the purpose of processing your request. The legal basis of your data processing is described in art. 6.1-b of the Regulation ("Performance of a contract to which the data subject is party"). Your personal data and those of your accompanying person, if any, will be stored only for the time necessary to process your request.

Data will be processed using paper and computer tools.

Your personal data will be processed by the Public Relation Office employees or other collaborators, acting in compliance with specific instructions on objects and purposes of the data processing. Furthermore, your personal data could be disclosed for the purposes stated above to third parties, appointed data processors, providing ancillary or instrumental services to the co-data controller, or to independent data controllers, for the purpose of processing your request or to comply with the law (e.g. Volotea). An updated list of all appointed parties can be requested to the Data Protection Officer or the data controller, at the addresses listed below.

You are free to provide your personal data and those of your accompanying person, if any; however, failure to provide personal data could result in the impossibility to process your request. You will have to inform your accompanying person on the purposes and methods of his/her personal data processing indicated in this privacy statement.

In your quality of data subject, you have the right to obtain from the co-data controllers authorization to access, delete, and to limit or deny the processing of your personal data ([art. 15 et seq., Regulation - Right of access by the data subject](#)). Should you deem that your personal data has been processed in breach of the Regulation, you have the right to [file a complaint](#) to the Italian Data Protection Authority (Art. 77, Regulation) or to start judicial proceedings (Art. 79, Regulation).
