He/she will be involved in the design process, ensuring that spaces are adequate for their intended use and that they meet the requirements of research and medical equipment installation.

- University degree in the scientific-technological sector.
- English proficiency (oral and written).
- Good knowledge of the main computer applications for project file classification, CAD, and database.
- At least 5 years of professional experience in hospital-related design and realization or in the field of research or hospital equipment, preferably in an international context.
- Professional experience installing clinical equipment and in hospital construction, and purchasing, delivering, start-up and putting into service of equipment.
