This is a call for applications for the selection of

Anesthesiologists for COVID-19

With facilities in Campania, Lazio, Sicily, and Tuscany, UPMC Italy (the Italian division of UPMC- <https://www.upmcitaly.it/en/>) is a leader in patient care, biomedical research, telemedicine, IT development and consulting services in areas related to medicine and research. UPMC Italy's clinical and scientific activity mainly focuses on transplantation and oncology, but also involves other specialties: from emergency medicine to neurosurgery, from preventive medicine to cardiac surgery.

ISMETT (Istituto Mediterraneo per i Trapianti e le Terapie ad Alta Specializzazione) is one of the most state-of-the-art and technologically-advanced medical centers in Italy, managed by UPMC (University of Pittsburgh Medical Center) in partnership with Civico Hospital and the Ri.MED Foundation. The Italian Ministry of Health has acknowledged ISMETT as a government-approved research hospital or Istituto di Ricovero e Cura a Carattere Scientifico (IRCCS) in the area of "End-stage organ failure treatment and research".

In consideration of the COVID-19 health emergency, we are issuing a call for applications for the selection of medical specialists/postgraduate students in Anesthesia and Critical Care, to provide clinical and medical care in order to meet the current related needs in the community.

The type of contract offered (which will include self-employment and collaboration contracts) will be commensurate with the qualifications, experience and skills of the selected applicants. The remuneration will take into account the type of activity requested and will therefore be of considerable interest.

This call remains open until all clinical care needs related to the COVID-19 pandemic are met.

All candidates will be expected to possess the following **requisites** at the time of their application:

A. Specialists (Ref. ANC/20)

- Degree in Medicine and Surgery recognized in Italy, or equivalent title.
- Medical license.
- Enrollment in the professional board.
- Postgraduate diploma in Anesthesiology and Critical Care recognized in Italy or equivalent title.
- Candidates under 50 years of age will be given preference.

B. Postgraduate students (Ref. ANSC/20)

- Degree in Medicine and Surgery recognized in Italy, or equivalent title.
- Medical license.
- Enrollment in the professional board.

- Enrollment in the last or penultimate year of the postgraduate diploma in Anesthesiology and Critical Care.
- Candidates under 50 years of age will be given preference.

The workplace is **Palermo**.

UPMC Italy reserves any and wider sole right of discretion in assessing applicants and the eligibility of their applications.

Only applicants not excluded under the provisions articulated in Legislative decree 165/2001, art. 53, para. 16-ter, and subsequent modifications and amendments (General Rules Governing the Work of Public Administrations), can participate in this selection.

After reading the privacy statement and authorizing the processing of their personal data (EU Regulation 2016/679), applicants of both sexes (Law 903/77) are requested to fill out the on-line application form available at <https://selezioni.ismett.edu/?lang=en>. When filling out the on-line application form, applicants will be requested to attach their CV.

At the end of the process, applicants will be requested to state, by means of a self-declaration, that they possess the requisites listed under this call for applications.

All communications will be e-mailed to the address stated by the applicant when submitting his/her application.

Only applications submitted on-line (<https://selezioni.ismett.edu/?lang=en>) with an attached CV will be taken into consideration.

Under penalty of exclusion, at the request of the company at any time during the selection process and within the mandatory deadline, applicants must provide evidence of the requisites stated in their self-declaration. Should any preliminary verification show a discrepancy with any statement submitted by an applicant, the latter will be excluded from the selection process, and any negotiation permanently suspended.

Personal data included in the CV will be processed by UPMC Italy and IRCCS ISMETT for selections for this or other similar positions. Applicants are requested to not include sensitive data (e.g., on health status), unless strictly necessary.
