ISMETT (Istituto Mediterraneo per i Trapianti e le Terapie ad Alta Specializzazione) is one of the most state-of-the-art and technologically-advanced medical centers in Italy, managed by UPMC (University of Pittsburgh Medical Center) in partnership with Civico Hospital and the Ri.MED Foundation. The Italian Ministry of Health has acknowledged ISMETT as a government-approved research hospital or Istituto di Ricovero e Cura a Carattere Scientifico (IRCCS) in the area of "End-stage organ failure treatment and research".

In consideration of the COVID-19 health emergency, we are issuing a call for expressions of interest for the position of nurses who will provide clinical care to meet the current related needs in the community.

This call remains open until all clinical care needs related to the COVID-19 pandemic are met.

All candidates will be expected to possess the following requisites and preferred qualifications at the time of submitting their expression of interest, which must be specified in the on-line form.

Requisites:

- Nursing school university degree or equivalent title.
- Enrollment in the Italian Board of Registered Nurses.

Preferred qualifications:

- Prior experience in an intensive care unit.
- University degree with a final mark of at least 105/110 or higher (candidates are requested to state their final mark when submitting their on-line application).
- Under 50 years of age.
- Immediate availability please specify on the online form, under Other relevant information, your availability to accept a possible job offer (e.g., immediate, in 30 days, etc.).

English proficiency, knowledge of main Office applications, excellent teamwork and stress management skills are instrumental to the role.

The workplace is **Palermo**.

ISMETT reserves any and wider sole right of discretion in assessing applicants and the eligibility of their applications.

Only applicants not excluded under the provisions articulated in Legislative decree 165/2001, art. 53, para. 16-ter, and subsequent modifications and amendments (General Rules Governing the Work of Public Administrations), can participate in this selection. All communications from ISMETT will be e-mailed to the address stated by the applicant when submitting his/her expression of interest.

After reading the privacy statement and authorizing the processing of their personal data (EU Regulation 2016/679), applicants of both sexes (Law 903/77) are requested to fill out the on-line application form available at https://selezioni.ismett.edu/?lang=en. When filling out the on-line application form, applicants will be requested to attach their CV.

At the end of the process, applicants will be requested to state, by means of a self-declaration, that they possess the requisites listed under this call for applications. Incorrect, unclear, or incomplete information in the on-line form could result in a non-eligibility for the selection.

Only expressions of interest submitted on-line (https://selezioni.ismett.edu/?lang=en) with an attached CV will be taken into consideration.

On the grounds of the current need and urgency, priority in appointing the position will be established based on the chronological order of submissions of applications and the availability of the candidate.

Under penalty of exclusion, at the request of the company at any time during the selection process and within the mandatory deadline, applicants must provide evidence of the requisites stated in their self-declaration. Should any preliminary verification show a discrepancy with any statement submitted by an applicant, the latter will be excluded from the selection process, and any negotiation permanently suspended.

Also in consideration of the situation of uncertainty associated with the progression of the COVID-19 emergency, IRCCS ISMETT reserves the right to revoke and/or invalid or definitively suspend the selection at any time, with no obligation to notify candidates and with no right for the latter to raise any right or claim whatsoever.
