The Department of Anesthesia and Intensive Care is responsible for all perioperative phases, including ERAS (Enhanced Recovery After Surgery) programs for all surgeries and/or Acute Pain Service. It also manages a multidisciplinary 20-bed ICU and about 1,100 admissions every year. Since 2009, an ECMO-TEAM rescue program has been in operation.

Thanks to the available state-of-the-art technology, after completing an appropriate orientation and training program, the newly-hired specialist will be able to manage the most complex cases from an anesthesia and reanimation standpoint. The selected candidate will also have the opportunity to review and practice all anesthesia and critical area procedures at ISMETT, such as positioning an ECMO, IABP or a pulmonary catheter, performing a percutaneous tracheostomy, and using a transesophageal echocardiogram for diagnostic and therapeutic purposes.
