## **1 Radiation Oncologist (Ref. MR UPMC/22 TI)**

The Radiation Oncologist will work at the UPMC Hillman Cancer Center Villa Maria Advanced Radiotherapy Center in Mirabella Eclano, Avellino, which offers radiation therapy treatments for oncological diseases, also in agreement with the National Health System. The Radiation Oncologist performs all appropriate medical (and relevant administrative) duties related to daily procedures: first visits, indication to radiation therapy, follow-up assessments and during treatments, CT simulation, contouring and treatment planning, care plan approval, CBCT (Cone Beam Computed Tomography) approval.

### **Requisites:**

- Degree in Medicine and Surgery or equivalent title obtained from a foreign university (recognized in Italy);
- Postgraduate diploma (recognized in Italy) in Radiotherapy or equivalent title;
- Enrollment in the professional board.

### **Preferred qualifications:**

- Knowledge of Varian linear accelerators and network, including the ECLIPSE/HYPERARC planning system;
- Knowledge of the BrainLab system with Elements planning software included;
- BLS – ACLS certification;
- Documented work/training experience at highly specialized centers providing stereotactic radiotherapy (SRS/SBRT) and image-guided radiotherapy (IGRT) services;
- Scientific production rated with the H-index.

English proficiency, team-working and good stress management skills **are also instrumental to the role.**

The workplace is the **Province of Avellino.**
