

IRCCS ISMETT

is issuing a call for applications for the following **no-term position**:

Nurse (Ref. Inf/22)

The purpose of this call is to create a list, which will have a maximum validity of 36 months, of eligible candidates ranked in order of merit, to which IRCCS ISMETT reserves the right to refer for potential future working contracts.

Istituto Mediterraneo per i Trapianti e Terapie ad Alta Specializzazione (ISMETT) is a multi-organ transplant center and high-specialty hospital established by means of an international not-for-profit public-private partnership between the Region of Sicily, Ri.MED Foundation, and UPMC (University of Pittsburgh Medical Center), which is responsible for its operational management. The Italian Ministry of Health has acknowledged ISMETT as a government-approved research hospital or Istituto di Ricovero e Cura a Carattere Scientifico (IRCCS) in the area of “End-stage organ failure treatment and research”. ISMETT is one of the few Joint Commission International (JCI) accredited hospitals in Italy since 2009, and one of only six Italian hospitals with ERMRA HIMSS Stage 6 certification.

Within the scope of the assigned unit, the nurse guarantees prompt, intensive, and continuous patient care, in compliance with ISMETT’s policies.

Applicants must meet the requisites and preferred qualifications of this call when filing the application and state them in the online form.

Requisites:

- University degree qualifying for the nursing profession, or other equivalent title (for the application to be examined, applicants are requested to indicate the final mark in the appropriate field of the online form).
- Enrollment in the Italian Board of Registered Nurses.

Preferred qualifications:

- Final mark of 105/110, or higher.
- First-level master’s degree in Critical Care.
- Previous working experience in ICU, cardiac surgery, and abdominal surgery.
- Work experience in a foreign country.

English proficiency, knowledge of main Office applications, excellent teamwork and stress management skills, and an availability to spend training periods abroad are also instrumental to the role.

The workplace is Palermo.

Only applicants not excluded under the provisions articulated in Legislative decree 165/2001, art. 53, para. 16-ter, and subsequent modifications and amendments (General Rules Governing the Work of Public Administrations), can participate in this selection.

Information concerning this selection will be notified to candidates through the official website in the “Work with us” section (www.ismett.edu). Applicants will be expected to access this information from the above-mentioned website.

IRCCS ISMETT reserves any and wider sole right of discretion in assessing the candidates to be included in the list of eligible individuals.

After reading the privacy statement and, if necessary, authorizing the processing of their personal data (EU Regulation UE 2016/679), applicants of both sexes (Law 903/77) are requested to fill out the online application form available at <http://selezioni.ismett.edu>.

The online form must be filled out paying particular attention to the requisites and preferred qualifications indicated in this call for application. Filling out the online application form in an incomplete, approximate, or incorrect manner may lead to considering the applicant not eligible to perform the tests.

When filling out the online form, applicants will be requested to attach their CV. Being an integral part of the application, the Chart linked here [Selezione Infermiere \(Rif. Inf/22\)](#) must also be filled out. Please note that applicants will be admitted to an interview based on the information included in the above-mentioned Chart.

Applicants are therefore required to:

- fill out the online form – indicating the selection code
- submit the CV – to be attached when filling out the online form
- fill out the Chart (to be found at the link above).

A mere generic statement to meet all the requirements, the failure to fill out the Chart, and sending the application in ways other than the one provided for in this document will result in the applicant’s exclusion from the selection process.

IRCCS ISMETT declines any responsibility for non-delivery of communications due to incorrect email addresses provided by applicants upon submitting their online applications.

Applicants shall not include any certified electronic mail addresses in the “Email” field of the online form, but only email addresses.

Failure to include email addresses in this field will result in the inability to deliver communications related to the selection process.

The deadline to submit the applications is **August, 31 2022**.

Please note that selection records are confidential documents for internal use only and may not be disclosed.

All applicants commit, at any time during the selection process, and if requested by IRCCS ISMETT, to provide the documentation certifying the stated possession of the requisites within the requested deadline.

Should any preliminary verification show a discrepancy with any statement submitted by an applicant, the latter will be excluded from the selection process, and any negotiation permanently suspended.

A list of suitable candidates will be drafted ranked in order of merit, with a maximum validity of 36 months, to which IRCCS ISMETT reserves the right to refer for potential future working contracts. The list will contain the names of the persons deemed eligible at the sole discretion of IRCCS ISMETT. Inclusion in the list entails no commitment on behalf of IRCCS ISMETT to start a professional collaboration with that person, nor any rights of preference for prior and different selections or rankings at IRCCS ISMETT.

The finalization of the employment contract is subject to the submission of the documentation proving that the applicant meets the requirements. Candidates unable to provide the requested documentation within the mandatory and final deadline indicated by IRCCS ISMETT based on its unquestionable organizational needs, for any reason whatsoever even if beyond their control, will be excluded from the selection regardless of their ranking.

IRCCS ISMETT reserves the right to revoke and/or invalid or definitively suspend this selection at any time, with no obligation to notify applicants, and with no right for applicants to raise any right or claim whatsoever.

Personal data included in the CV and any other information collected during the selection will be processed by IRCCS ISMETT and UPMC Italy in their role of joint controllers, for selections for this or other similar positions. Applicants are requested to not include sensitive data (e.g., on health status), unless strictly necessary.
