1 Nutritionist (Ref. Nu/22 TD)

ISMETT (Istituto Mediterraneo per i Trapianti e Terapie ad Alta Specializzazione) is a multi-organ transplant center and high-specialty hospital established by means of an international not-for-profit public-private partnership between the Region of Sicily, Ri.MED Foundation, and UPMC (University of Pittsburgh Medical Center), which is responsible for its operational management. The Italian Ministry of Health has acknowledged ISMETT as a government-approved research hospital or Istituto di Ricovero e Cura a Carattere Scientifico (IRCCS) in the area of "End-stage organ failure treatment and research". IRCCS ISMETT is one of the few Joint Commission International (JCI) accredited hospitals in Italy since 2009, and one of only six Italian hospitals with EMRAM HIMSS Stage 6 certification.

In the scope of the research project "RF-2019-12371145 – Role of nutritional intervention for the treatment of sarcopenia in cirrhotic patients with refractory ascites candidate to transverse hepatic intrahepatic shunt placement and identification of prognostic factors related to clinical outcome", the Nutritionist will be responsible for drafting nutritional plans and for the according follow-up of patients enrolled in the study. As part of the clinical oncology program, the Nutritionist will also provide dietary and nutritional support to IRCCS ISMETT patients, including assessing the nutritional status, preparing the plan according to clinical guidelines, evaluating outcomes, nutrition training for staff and patients, identifying nutritional risks of patients, and developing interventions based on specific criteria.

Applicants must meet the requisites and preferred qualifications of this call when filing the application and state them in the on line form.

Requisites:

• Master's Degree in Biological Sciences or Human Nutrition Sciences or equivalent title under the current laws (applicants are requested to indicate their final mark in the appropriate field of the on line form. In the absence of this information, the application will be considered incomplete).

- Professional license.
- Enrollment in the professional board of Nutritionists provided for by the law.
- At least one year of previous working experience in the role.

• Compliance with mandatory vaccination for the prevention of SARS-CoV-2 infection referred to in art. 4 and 4-ter of Decree 44/2021 (without prejudice to unenforceability of the vaccination

Preferred qualifications:

- Experience in the field of oncology nutrition.
- PhD in Oncology and/or publications in this area.
- Master's in Oncology Nutrition.

The ideal candidate has experience in assessing nutritional status, planning customized diets, taking part in and conducting clinical studies in nutrition, and has knowledge of the main IT applications and of written and spoken English.

Strong motivation, flexibility, stress management, problem-solving skills, and good interpersonal and teamwork skills complete the role.

The workplace is **Palermo**.
